NAME OF WORK: INVITATION OF TENDER FOR INSTALLATION OF STATE OF ART PYLON IN JSCA INTERNATIONAL STADIUM COMPLEX, H.E.C. CAMPUS, DHURWA, RANCHI.

1.0 BACK GROUND: -

J.S.C.A Stadium Complex besides the cricket grounds and pavilions, have many other facilities viz Country Cricket Club, Academy block, car parking area, Tennis court, Swimming pool, Banquet halls, etc. It is proposed to install a Pylon at its main entrance (North Gate) showing direction to locate each facility. There is already an old Pylon which shall be replaced by the proposed one.

J.S.C.A. intends to select a reputed agency for installation of 'State of Art' PYLON near north main gate on concept to commissioning basis. The quality of work shall have the highest degree of 'precision and finish'.

2.0 SCHEDULE OF BIDDING PROCESS AND EVALUATION: -

Bids shall be submitted in two parts viz technical and financial. Technical part shall be opened first and it will be evaluated as per the parameters given in following paras. If necessary, the bidders shall be required to give a presentation for their proposal.

After the evaluation of bids in terms of technical/ creative presentation, the bidder, who score minimum 70 marks out of 100 in technical/ creative presentation will be eligible and qualified for opening of their financial bid.

2.1 EVALUATION OF TECHNICAL BID

It shall be evaluated as under:

3.0 <u>SCOPE:</u> -

The scope shall include the following:

3.1 Idea and concept:

Preparation and submission of drawings showing design, shape and size, execution plan giving details of materials to be used for various components viz. structure, cladding, letterings, lightings, etc.

- 3.2 Dismantling of existing Pylon including its electrical works and concrete foundation.
- 3.3 Supply, fabrication and installation of new Pylon which will include:
 - i. New foundation as per approved design;
 - ii. Fabrication of support structure as per approved design;
 - iii. Cladding work as per approved design;
 - iv. Lettering as per approved chart (to be given by J.S.C.A). Lettering shall be engraved/ laser cut/ water jet cut to achieve highest degree of precision and beauty;
 - v. Adequate number of Invisible LED light fittings uniformly and thoroughly illuminating the façade i.e. maintaining uniform lux level at each point
 - vi. Any other job deemed necessary for durability and making it '*State of Art*' in letter and spirit.
- vii. Beautifying the surrounding area.

4.0 PLACE AND DATE OF SUBMISSION OF BIDS :-

Bids can be submitted till 12:00 noon on 30.7.2020 in the office of C.E.O. in Amitabh Choudhary Pavilion at J.S.C.A. International Stadium Complex, Dhurwa, Ranchi.

5.0 EARNEST MONEY : -

Earnest money deposit shall be Rs.10,000/- (Rupees Ten Thousand only) in the form of Demand Draft payable to Jharkhand State Cricket Association at Jamshedpur.

6.0 TIME OF COMPLETION : -

The work should be completed within 45 (forty-five) days from the date of issue of LOI.

7.0 DEFECT LIABILITY PERIOD : -

The Defect Liability Period shall be one year from the date of handing over.

8.0 <u>PRICE</u> : -

The quoted price shall be a Lump sum exclusive of GST.

9.0 <u>PAYMENT</u>: -

- i. 20% of total price shall be paid after approval of design and after signing of agreement.
- ii. Balance 80% shall be paid after completion of work and ascertainment by J.S.C.A. that work was carried out satisfactory as per contract conditions.

10.0 <u>WARRANTY: -</u>

- 10.1 The contractor shall furnish a minimum seven (7) years warranty in original from the manufacture of non-metalized Micro prismatic retro reflective sheeting for satisfactory field performance including stipulated retro reflectance of the retro reflective sheeting.
- 10.2 The contractor shall also furnish a certificate that the materials supplied against the assigned work meets all the stipulated requirements and carry the stipulated warranty. The warranty shall also cover the replacements obligations by the sheeting manufacturer as well as contractor for replacement/ repairing/ restoration of the retro reflective efficiency.
