Packet-1 shall contain following documents:

- (iii) Experience certificate for managing similar events (atleast two);
- (iv) Earnest Money (refundable) :- Rs.10,000/- (Rupees Ten Thousand only) in the form of Demand Draft payable to "Jharkhand State Cricket Association" at Jamshedpur;
- (v) Tender Processing Fee (non-refundable):- Rs.5,000/- (Rupees Five Thousand only) in the form of Demand Draft payable to "Jharkhand State Cricket Association" at Jamshedpur.

Packet- 2 shall contain only the price schedule.

Packet- 1 shall be opened first and Packet - 2 shall be opened only for those agencies whose all documents including the earnest money are found in order.

SPECIAL CONDITIONS

1.
 - I. All guards/supervisors/security officers must be duly verified through their background documents of previous service and ex-serviceman record.
 - II. The Agency shall deploy/withdraw any manpower at any locations in consultation with J.S.C.A.
 - III. The Agency shall arrange to get their security personnel to go through an orientation course before deploying them on duty. No guard should be put on duty without taking orientation training.
 - IV. The Agency shall regularly conduct drills of their personnel and arrange to provide training to their guards and supervisors for improving skills, reflexes and fitness as per the requirement.
 - V. Food to the persons deployed shall be given by the agency.
 - VI. Guards/supervisors/security officer shall report at a time as per direction of JSCA.
