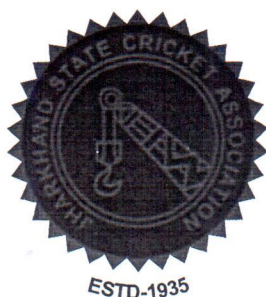

Subject: Clarifications regarding Shri Uma Maheswar Rao, Shri Yugesh Kumar Singh and Shri Abhay Kumar Singh.

Ref: Letter Nos. 11/2025 dated 10.05.2025 and 12/2025 & 13/2025 dated 11.05.2025.


Dear Sir,


With reference to the above-mentioned letters, we would like to place on record the following clarifications pertaining to the cases of Shri Uma Maheswar Rao, Shri Yugesh Kumar Singh and Shri Abhay Kumar Singh:

1. We must state at the outset that the voter list was verified on the basis of the affiliation forms available in the office and that was the only material taken into consideration. In the case of Shri Abhay Shankar Singh, it is clarified that his name did not appear in the affiliation form submitted by Vikas Cricket Club for the year 2024–25, and therefore, he was not included in the voter list as a representative of the said club. However, his representation was submitted under the name of RSB Transmissions (I) Ltd., and due to a clerical oversight, the photograph, which was to serve as proof of his representation, was not attached at the time of verification. We now attach herewith a photocopy of the said affiliation form for 2024–25, which contains the relevant details.
2. The affiliation form submitted by the Jamtara District Cricket Association initially listed Shri Nigam Krishna Singh and Shri Shivjee Singh as President and Secretary. However, the post of Secretary was later filled by Shri Yugesh Kumar Singh, whose nomination was communicated to the JSCA and approved in the JSCA Committee meeting on 18.02.2025 (minutes attached). The omission of Shri Yugesh Kumar Singh's name was due to a lapse in communication from the JSCA office. Thus, the name of Yugesh Kumar Singh as the Secretary of Jamtara District Cricket Association did not find mention on account of lack of proper communication from the JSCA office and is an oversight.
3. So far as the case of Uma Maheswar Rao is concerned, he had contested the JSCA elections for the single post of representative of schools/clubs/institutions in the elections held in 2022. At that time, he was the Secretary of the Student's Club and in order to join the Committee of Management of JSCA he had to forego his post in the club. This fact stands recognised by the club, which has as a matter of fact duly intimated the JSCA at the time of submission of the affiliation form itself that the new secretary had to be nominated only because the post became vacant on the resignation of Uma Rao and no sooner Uma Rao will resign from his post in the JSCA Committee of Management, he would stand reinstated on the post of secretary of the club. It has also to be kept in mind that non-inclusion of his name in the voter list would mean that any person contesting as a representative of the affiliated units, be a district or the clubs/schools/institutions will necessarily have to undergo a cooling off period and cannot contest in two consecutive elections of the JSCA Committee of Management, which in our view is not contemplated in the JSCA constitution. A new affiliation form was duly circulated to the Committee of Management and no objection has come from any quarter.


