Name of Work: Design, Supply, Installation of Irrigation System for JSCA Cricket ground at Katras, Dhanbad.

INVITATION OF TENDER

Tenders are invited from experienced and bonafide agencies for "Design, Supply and Installation of Irrigation System for JSCA Cricket ground at Katras, Dhanbad".

1. SCOPE OF WORK:

- 1.1. Design, Supply and Installation of Irrigation System for a cricket ground having 72m radius with all material, labour, installation, transportation, testing and commissioning and maintaining the system for a period of one year. The system shall be connected with a water sump of appx. 60,000 litres capacity. The system shall be run with 3 phase electricity provided near the sump. The system shall be so designed to ensure for full coverage of ground with a uniform rate of flow

2. ELIGIBILITY CRITERIA: -

- 2.1. Bidder must fulfill the following eligibility criteria
- ❖ Should have valid GST registration;
 - ❖ Must have experience in similar type of works.

3. AUTHORITY OF PERSON SIGNING TENDER DOCUMENT: -

- 3.1. A person signing the tender form or any documents forming part of tender/contract on behalf of the bidder, should be authorized to do so. A letter of authority should be submitted along with tender.

4. EARNEST MONEY: -

- 4.1. EMD of Rs.5,000/- (Rupees Five Thousand only) in the form of Demand Draft payable to Jharkhand State Cricket Association at Jamshedpur.

5. PRICE:

- 5.1. Party to quote Lump sum price. Quoted price shall include, all cost of material labour, transportation, handling, taxes, incidentals, overheads, margin, etc. as applicable excluding GST which shall be added separately quoted price

6. TENDER SUBMISSION:

- 6.1. Tender documents shall be submitted in two parts (packets):-

6.1.1. Part-1 Technical

(Packet-1) shall contain following documents:

- ❖ Covering letter of Tenderer;
- ❖ Credentials that makes bidder eligible i.e. copy of order and completion certificate;
- ❖ Demand Draft for EMD of Rs.5,000/- (Rupees Five Thousand only) in favour of Jharkhand State Cricket Association payable at Jamshedpur;
- ❖ Any clarification tenderer may like to seek.

6.1.2. Part-2 Financial

(Packet- 2) shall contain only the price schedule.

Packet- 1 shall be opened first. **Packet- 2** shall be opened only for those agencies whose all documents including the earnest money are found in order. Bidders shall have no claim for such rejection.

7. PLACE AND DATE OF SUBMISSION OF TENDER:

- 7.1. Bids can be submitted till 04:00 PM on 26nd June, 2025 in the office of C.E.O. in 1st Floor of Amitabh Choudhary Pavilion at J.S.C.A. International Stadium Complex, Dhurwa, Ranchi.

8. PAYMENT:

- 8.1. 40% after receipt of all material at site
8.2. 40% after completion of work
8.3. 10% after satisfactory commissioning
8.4. 5% after completion of one year of commissioning
8.5. 5 % after warranty period

9. MATERIAL SPECIFICATION:-

- 9.1. Makes of all materials and equipments shall be of best quality and the same shall be got approved before procurement

10. TIME OF COMPLETION:-

- 10.1. The work should be completed within 30 (thirty) days from the date of issue of LOI.

11. PERFORMANCE GUARANTEE TEST:-

- 11.1. The contractor after completion of the work and commissioning of the system shall perform the following test.
11.2. Run the complete system for a continuous period of 10 hrs successfully to water the ground. In the event if the test is not completed without any fault, the contractor shall repeat the test

12. DEFECT LIABILITY PERIOD:-

- 12.1. The defect liability period shall be one year from the date of commissioning of system

13. WARRANTY PERIOD:-

- 13.1. The warranty period shall be two years from date of completion/commissioning of system. The pump and other accessories supplied shall stand warranty of two years from date of commissioning. In case during the warranty period the contractor shall replace the defective parts with new ones without any price implication to Employer

14. NO COMPENSATION FOR TENDER SUBMISSION:

- 14.1. If desired, the intending bidder may visit the site under intimation to us, before submission of tender. Intending tenderer shall submit their tender at their own cost and no compensation shall be payable for expenditure incurred, if any.
