NOTICE INVITING TENDER

Jharkhand State Cricket Association (J.S.C.A.) invites tenders from bonafide and competent agencies for "Food services in M.S. Dhoni Pavilion" during 1st ODI match between India vs South Africa on 30th November, 2025 at J.S.C.A. International Cricket Stadium Complex, H.E.C. Campus, Dhurwa, Ranchi.

The job comprises of two parts under Schedule - A and Schedule - B.

Schedule - A is for areas at Level-1, Level-2, Level-3 and Level-5 where the scope includes preparation, supply and service of food beverages in those areas. Payment for the job shall be made by JSCA at agreed rates.

Schedule - B is for Level-6 having a seating capacity of appx. 1200 seats where food items are to be sold to spectator/public at approved rates of JSCA. Vendor shall have to pay a fee of Rs.10,000/- (Rupees Ten Thousand only) for allowing such sale by JSCA at Level-6.

The number indicated in Schedule are total seating capacity but actual number may vary depending upon issue of tickets where payment is to be made by JSCA, it shall be made for the actual number supplied.

Tenders shall be submitted till 04.00 PM on 10th September, 2025 in the office of Honorary Secretary at Level -2 of Amitabh Choudhary Pavilion at J.S.C.A. International Stadium Complex, Dhurwa, Ranchi.

The Jharkhand State Cricket Association reserves the right to reject any or all offers or split the job without assigning reasons whatsoever.

TERMS & CONDITIONS:

1. **PREAMBLE:-**

It is a prestigious event at J.S.C.A. International Stadium Complex. Only capable agencies meeting the eligibility criteria and confident of providing the services should submit their offer.

2. **SCOPE OF AGENCY/BIDDER:-**

It will be responsibility of the Agency/Bidder to provide all labour, materials and any other items necessary to carry out the services. They will be also responsible to fulfill all statutory requirements under shops & establishment, health services and any other provisions under the law for carrying out such business. All the stalls shall be furnished by the JSCA but it will be responsibility of vender to keep the stalls hygienic during the business hour. In addition to above, sufficient numbers of dustbins shall be also provided by the vendor to maintain cleanliness. In case of sale (Level-6), Agency/Bidder shall be required to display at a prominent location in the shop the list of food items available with approved rate of each time.

3. **FACILITIES TO BE PROVIDED BY J.S.C.A.:**

Kitchen space at Level-4 free of charge.

4. **TERMS & CONDITIONS: -**

- i. Agency will deploy technically trained, experienced and suave staff for the above-mentioned job. The serving caterers should be smart, well dressed with high standard of personnel hygiene. Vendor will ensure that uniforms are of one single type/varieties.
- ii. Agency will take all measures and precautions to prevent breakage & loss of property under their custody and control. In case of any damage/loss, then contractor/vendor shall be liable to compensate it as decided by J.S.C.A.
- iii. Agency will ensure customer satisfaction by providing good quality hygienic food.
- iv. Agency will be responsible to ensure wholesome, well cooked and tasty meals to be served in time to the audience.
- v. J.S.C.A. will have administrative control over the services provided by Agency.
- vi. Any point not covered in the terms & conditions pertaining the same shall be mutually discussed and resolved.
- vii. In case of any dispute or difference of opinion, the decision of J.S.C.A. will be final & binding
- viii. Agency must depute some senior official from time to time to have interaction with J.S.C.A. officials.
- ix. All manpower to be deputed by Agency should be above 18 years and below 45 years of age.
- x. The staff of Agency should wear uniform to be supplied by Agency.

- xi. Agency has to comply with all the statutory rules and regulations including contract labour act, workman compensation act, employee insurance act, personal accident insurance, provident fund and any other relevant laws, rules and regulation etc that may be applicable from time to time.
- xii. Agency will be solely responsible for any violation of labor enactment with respect to their manpower.
- xiii. J.S.C.A. will have discretion to advise the Agency to remove from services any of their person or employee due to misbehavior and misconduct.
- xiv. Successful vendor shall be issued accreditation cards for the work force who shall be allowed entry and exit as per direction of JSCA.
- xv. Rates shall be inclusive of all types of taxes, duties etc as applicable.
- xvi. Water and electricity may be tapped from JSCA mains free of charge.

5. BID PROCESS:-

Tender documents shall be submitted in two packets in a sealed envelope, as under. Both envelopes shall be put into one cover envelop with name of Group quoted super scribed on it.

Envelop - 1 will contain:-

- D.D. of Rs.1,00,000/- (Rupees One Lakh only) towards Earnest Money (refundable). Earnest money shall be refunded to unsuccessful bidder and earnest money of successful bidder shall be converted into security deposit which will be refunded after successful completion of the match.
- Demand draft of Rs.10,000/- (Rupees Ten Thousand only) towards payment of fee for allowing sale at Level-6 in favour of "Jharkhand State Cricket Association" payable at Jamshedpur.
- Tender Processing Fee (non-refundable):- Rs.5,000/- (Rupees Five Thousand only) in the form of Demand Draft payable to "Jharkhand State Cricket Association" at Jamshedpur.

Envelop - 2 will contain:-

- The Price Bid for Schedule – A.

6. FAILURE TO COMPLY WITH AGREED PROVISIONS:-

If at any time, it is found that

- i. Quality of food served is not as per agreed terms and conditions;
- ii. Proper cleanliness and hygiene is not maintained;
- iii. Conduct of any employee is found intemperate or undignified or is detrimental to the interest of J.S.C.A.;
- iv. Charging higher rates than approved by J.S.C.A.;
- v. Or any other activity considered unlawful or against the spirit of this contract agreement, permission shall be withdrawn requiring the Agency to vacate the premises immediately. There will be no claim, whatsoever for pre-closure and their Earnest Money shall be forfeited, apart from proceeding against them in accordance with law.
