1. SCOPE OF WORK:-

The scope of work includes, but is not limited to, supply, repair and provision of items/equipment as per requisitions received from the following hosting venues:

- Usha Martin University (Amitabh Choudhary Cricket Stadium), Ranchi.
- MECON Stadium, Ranchi.
- Hazaribagh District Cricket Association.
- Keenan Stadium / College Ground / Telco Ground, Jamshedpur.
- Dhanbad Cricket Association.

2. ELIGIBILITY CRITERIA:-

- Valid GST registration.
- Proven experience in supply/repair/maintenance of cricket ground preparation equipment or allied works.

- The quoted price shall be inclusive of material, labour, transportation, handling, incidentals, overheads, margin, etc., **excluding GST** which shall be added separately.
