The Jharkhand State Cricket Association (JSCA) invites sealed quotations from reputed local manufacturers, authorized dealers and suppliers for the design, manufacture, supply, delivery, and installation of office furniture for its Affiliated District Cricket Associations and heavy-duty steel storage almirahs for the JSCA Stores at the JSCA International Stadium Complex, Ranchi.

Submission of Quotation:-

Interested bidders may submit their sealed quotations in the prescribed format upto 04:00 PM on 31st July, 2026 in the office of the C.E.O., Level-2, Amitabh Choudhary Pavilion, J.S.C.A. International Stadium Complex, Dhurwa, Ranchi. Quotations received after the stipulated date and time shall not be entertained.

Technical Terms & Conditions

1. The bidder must be a manufacturer, authorized dealer or supplier of office furniture.
2. The materials supplied shall conform to the items mentioned in the Schedule of Items.
3. The furniture shall be of standard quality, durable and free from manufacturing defects.
4. The successful bidder shall complete the supply and installation within 30 days from the date of issue of the Purchase Order.
5. A minimum warranty of one year shall be provided for all furniture items supplied.
6. Any defective or damaged item shall be replaced by the supplier free of cost during the warranty period.

Financial Terms & Conditions

1. The rates quoted shall be inclusive of GST, packing, forwarding, loading, unloading and installation charges.
2. Transportation charges shall be paid extra on actual basis, subject to submission of supporting documents and approval.
3. All office furniture items shall be delivered at the respective District Headquarters of the Affiliated District Cricket Associations and the steel storage almirahs shall be delivered at the J.S.C.A. International Stadium Complex, Dhurwa, Ranchi.
4. The quoted rates shall remain valid for a period of 30 (thirty) days from the last date of submission of quotations.
5. No extra charges, other than approved transportation charges on actual basis, shall be payable by the Association beyond the quoted rates.
6. Payment shall be released only after successful supply, installation, inspection and acceptance of the materials by the Association.
7. The bidder shall submit a valid GST invoice along with the bill for payment.
