NOTICE INVITING TENDER

The Jharkhand State Cricket Association (JSCA) invites sealed tenders from bonafide and competent agencies for 'Providing Food and non-alcoholic beverages (except Campa Cola & its product) services at the following locations during 2nd T20I match between India vs West Indies on 9th October, 2026 at J.S.C.A. International Cricket Stadium Complex, H.E.C. Campus, Dhurwa, Ranchi.

1. Wing - A & Wing - B (appx. 15100 seating capacity);
2. Wing - C & Wing - D (appx. 14000 seating capacity);
3. East & West Hills (appx. 1300 seating capacity); and
4. Premium Terrace (appx. 2900 seating capacity).

However, the numbers indicated above represent the total seating capacity. The actual number of spectators may be less depending upon the number of tickets issued.

Tender documents shall be submitted in two packets in a sealed envelope, as under:

Packet-1 shall contain:-

- i. Experience/Eligibility documents as specified under the Pre-Qualification Criteria.
- ii. FSSAI Licence/Registration and GST Registration
- iii. Signed copy of Annexure-1: Rates Fixed for Food Items.
- iv. Earnest Money (refundable): Rs.1,00,000/- (Rupees One Lakh only) in the form of Demand Draft payable to "Jharkhand State Cricket Association" at Jamshedpur.
- v. Tender Processing Fee (non-refundable): Rs.5,000/- (Rupees Five Thousand only) in the form of Demand Draft payable to "Jharkhand State Cricket Association" at Jamshedpur.
- vi. Signed copy of Annexure-3: Undertaking to be Given by Owners of All Food Courts.

Packet No.-2 shall contain:-

- i. Price Bid as per Annexure-2.

Packet No. 1 shall be opened first. Packet No. 2 shall be opened only for those agencies whose submitted documents, Earnest Money and Tender Processing Fee are found to be in order.

TERMS & CONDITIONS

1. PREAMBLE:-

It is a prestigious event at J.S.C.A. International Stadium Complex. Only capable agencies meeting the eligibility criteria and confident of providing the required services should submit their offer.

2. SCOPE OF AGENCY/BIDDER:-

- i. It shall be the responsibility of the Agency/Bidder to provide all labour, materials, equipment and other items necessary for carrying out the services.
- ii. The Agency/Bidder shall comply with all applicable statutory requirements, including those relating to food safety, shops and establishments, labour, health and hygiene and any other applicable laws, rules and regulations.
- iii. All stalls shall be furnished by JSCA; however, it shall be the responsibility of the Agency/Bidder to maintain the stalls in a clean and hygienic condition throughout the operating hours.
- iv. Adequate dustbins shall be provided by the Agency/Bidder at the allotted locations.
- v. The Agency/Bidder shall prominently display the list of approved food items and their approved rates at each stall.

3. PREQUALIFICATION CRITERIA :-

Bidder should fulfill following criteria and submit self-attested copies of the documents:

- i. Experience of at least three years in the food and beverage business as on the date of submission of the tender.
- ii. Valid FSSAI Licence/Registration, as applicable.
- iii. Valid GST Registration Certificate.
- iv. Experience in providing food and beverage services at major events such as ICC, IPL or other major/prestigious events.

4. FACILITIES TO BE PROVIDED BY J.S.C.A.:

JSCA shall provide space for each stall at pre-decided locations.

5. TERMS & CONDITIONS: -

- i. The Agency shall deploy technically trained, experienced and well-mannered staff for the services. Serving staff shall be smart, properly dressed and maintain high standards of personal hygiene. The Agency shall ensure uniformity in the uniforms provided to its staff.
- ii. The Agency shall take all necessary measures and precautions to prevent any breakage, damage or loss of property under its custody and control. In case of any damage or loss, the Agency shall be liable to compensate JSCA, as determined by JSCA.
- iii. The Agency shall ensure customer satisfaction by providing good quality and hygienic food.
- iv. The Agency shall ensure that wholesome, properly cooked and fresh food items are served in a timely manner to the spectators.
- v. JSCA shall have administrative control over the services provided by the Agency.
- vi. Any matter not specifically covered under these Terms & Conditions shall be decided by JSCA, in consultation with the Agency, wherever considered necessary.
- vii. In case of any dispute or difference of opinion arising in connection with the services, the decision of JSCA shall be final and binding on the Agency.

- viii. The Agency shall depute a senior official from time to time for coordination and interaction with JSCA officials.
- ix. All manpower deployed by the Agency shall be above 18 years of age and shall comply with all applicable legal requirements.
- x. The Agency shall comply with all applicable labour laws and statutory requirements relating to its manpower, including PF, ESI, Minimum Wages, Labour Cess and other applicable statutory dues and requirements, wherever applicable. The Agency shall be solely responsible for any non-compliance and all liabilities arising therefrom.
- xi. The Agency shall comply with all applicable requirements relating to contract labour, employees' compensation, insurance, provident fund and other applicable labour and statutory requirements.
- xii. The Agency shall be solely responsible for any violation of labour laws or statutory requirements in respect of its manpower and shall indemnify JSCA against any resulting claim, liability or penalty.
- xiii. The Agency/Bidder shall ensure that there is no actual, potential or perceived conflict of interest in connection with this tender or execution of the services. Any such conflict shall be disclosed to JSCA immediately. Failure to disclose the same may result in rejection of the bid, cancellation of allotment or termination of the contract.
- xiv. JSCA shall have the discretion to advise the Agency to remove any person or employee from the services on account of misbehaviour, misconduct or any act considered detrimental to the interests of JSCA.

6. FAILURE TO COMPLY WITH AGREED PROVISIONS:-

If at any time it is found that:

- i. The quality of food served is not as per the agreed terms and conditions;
- ii. Proper cleanliness and hygiene are not maintained;
- iii. The conduct of any employee is intemperate, undignified or detrimental to the interests of JSCA;
- iv. Higher rates than the approved rates are charged for any food article; or
- v. Any other activity is carried out which is unlawful or contrary to the terms and conditions of this tender/contract,

JSCA shall have the right to cancel the allotment/terminate the contract and require the Agency to vacate the premises immediately.

The Agency shall have no claim whatsoever for such pre-closure/termination, and its Earnest Money may be forfeited, without prejudice to any other action available to JSCA under applicable law.
