The Jharkhand State Cricket Association (JSCA) invites tenders from bonafide, competent and duly Licensed Agencies for providing '**Security Services**' during 2nd T20I match between India vs West Indies on 9th October, 2026 at J.S.C.A. International Cricket Stadium Complex, H.E.C. Campus, Dhurwa, Ranchi.

Security personnel shall be required on the match day as well as earlier for practice sessions and other requirements, as directed by JSCA.

Tender documents shall be submitted in two separate packets in a sealed envelope, as under::

Packet-1 shall contain:

- i. Registration Certificate of the Agency/Firm.
- ii. Valid licence/authorisation to operate as a Private Security Agency, as applicable.
- iii. Experience Certificate(s) evidencing successful handling of at least two similar events.
- iv. Earnest Money Deposit (refundable) of Rs.10,000/- (Rupees Ten Thousand only) in the form of Demand Draft in favour of "Jharkhand State Cricket Association", payable at Jamshedpur.
- v. Tender Processing Fee (non-refundable) of Rs.5,000/- (Rupees Five Thousand only) in the form of Demand Draft in favour of "Jharkhand State Cricket Association", payable at Jamshedpur.
- vi. Signed copy of Affidavit as per Annexure- 2.

Packet-2 shall contain: Price Bid as per Annexure-1.

Packet No. 1 shall be opened first. Packet No. 2 shall be opened only for those agencies whose submitted documents, Earnest Money and Tender Processing Fee are found to be in order.

GENERAL CONDITIONS

- i. All guards/supervisors/security officers must be duly verified through their background documents of previous service and ex-serviceman record.
- ii. The Agency shall deploy/withdraw any manpower at any locations in consultation with J.S.C.A.
- iii. The Agency shall arrange to get their security personnel to go through an orientation course before deploying them on duty. No guard should be put on duty without taking orientation training.
- iv. The Agency shall regularly conduct drills of their personnel and arrange to provide training to their guards and supervisors for improving skills, reflexes and fitness as per the requirement.
- v. Food and refreshments for the personnel deployed shall be arranged by the Agency at its own cost.
- vi. All guards, supervisors and security officers shall report for duty at the time and location specified by JSCA.
- vii. The Agency shall ensure that all deployed personnel are properly dressed in clean and prescribed uniform, with valid identity cards and necessary equipment as approved/directed by JSCA.
- viii. The Agency shall provide adequate supervision and shall ensure proper discipline and conduct of all personnel deployed.
- ix. The Agency shall immediately replace any security personnel found unsuitable, negligent, indiscipline or not complying with the instructions of JSCA.
- x. The Agency shall coordinate with JSCA, the Police/Security Authorities and other agencies deployed at the Stadium for effective security and crowd management.
- xi. The tentative requirement of security personnel at J.S.C.A. on daily basis are as under –

1	Supervisor	20
2	Security Guard (Gents & Ladies)	180

Note: The above quantities are tentative. JSCA may increase or decrease the manpower requirement depending upon the actual requirement. The Agency shall deploy additional manpower or withdraw manpower as directed by JSCA.

The Agency shall submit a detailed deployment plan immediately upon receipt of the Letter of Intent (LOI) for approval of JSCA.
