- iv. Earnest Money (refundable):- Rs.10,000/- (Rupees Ten Thousand only) in the form of Demand Draft in favour of "Jharkhand State Cricket Association" payable at Jamshedpur.
- v. Tender Processing Fee (non-refundable):- Rs.5,000/- (Rupees Five Thousand Only) in the form of Demand Draft in favour of "Jharkhand State Cricket Association" payable at Jamshedpur.

TERMS & CONDITIONS:

1. Rates shall include supply, transportation, installation, placement and removal of all items. The agency shall clear the site within two days after the match or as directed by JSCA.
2. All materials and equipment shall be of good quality, safe and suitable for the event. JSCA reserves the right to reject defective or unsuitable items.
3. All work shall be carried out as per the instructions and approval of JSCA officials. Bills shall be supported by duly acknowledged challans/work completion records. No advance payment shall be made. Payment shall be made after satisfactory completion, based on the actual work/items accepted by JSCA.
 - (i) Earlier Day (upto 4 days) :- 75% of the quoted rate.
 - (ii) Match Day :- 100% of the quoted rate.
4. Any additional work/item shall be undertaken only with the prior written approval of JSCA and at mutually agreed rates.
5. In case of delay or unsatisfactory performance, JSCA may get the work completed through another agency at the risk and cost of the successful bidder.
6. All arrangements shall be completed and ready for use at least two days before the match, i.e. by 7th October 2026, unless otherwise directed by JSCA. Payment shall be made only for the actual work/items accepted for the match.
7. The agency shall comply with all applicable labour laws, PF, ESI, Minimum Wages, insurance and other statutory requirements.
8. The agency shall ensure safe installation and operation of all structures, electrical equipment, generators and other items and shall be responsible for any loss, damage or accident arising from its negligence or defective work.
9. The agency shall provide adequate and competent manpower and supervisors and shall be responsible for their conduct and discipline.
10. JSCA shall have the right to inspect the work and materials at any stage and require replacement of defective or unsuitable items.
11. GST shall be payable extra, as applicable.
12. The successful bidder shall comply with all applicable Government, BCCI and JSCA requirements and submit the duly notarized Affidavit/Undertaking as per Annexure-2.
13. The decision of JSCA regarding the quality, quantity and acceptance of the work shall be final and binding.
